Team Requirements

- Minimum of 3 new Paid-As Emeralds+
- Must be in the PETL downline of the Diamond Leader

Emerald Qualifications

- Achieve Paid-As Emerald or higher for at least one week during the qualification period
(Current Status – Can't be higher than Paid-As Ruby in previous 4 weeks)
- Reach Paid-As Ruby or higher for at least two weeks during the qualification period (the Emerald week can count as one of the two)
- Develop two Paid-As Platinums within your PETL during the qualification period
Platinums do not need to be earned in the same week as the Emerald rank
Only one Paid-As Platinum per line of sponsorship will count toward the requirement
(Current Status of Paid-As Platinums can't be higher than Silver in previous 4 weeks)
- New Emeralds must register at least 10 Vitality Test Kits to new customers and/or new Brand Partners during the qualification period
- New Emeralds must earn the enroll 2 maximum amount at least once during the qualification period

WHO WILL JOIN YOU?

- The qualifying Diamond + plus one guest
- The 3 new Paid-As Emeralds + plus one guest
- The first two Diamonds in the personally enrolled tree of each Emerald+ may also qualify (space permitting)
